Hi Beckie,

Yesterday, you had questions regarding the s/c exemption and how it affects taxes with annexation into the RFA.

Here are the s/c exemption income level in Snohomish County:

If the annexation occurs and a taxpayer is on the s/c exemption program they will pay the RFA Regular (Fire) levy and EMS levy plus there is benefit assessment (the benefit assessment is not a tax it's a fee). Depending on their income level their property taxes may be reduced. The s/c exemption freezes the value and then if they qualify for Status A or B they would see a further reduction in value which results in pay less in property taxes.

Here's an example if a taxpayer with s/c exemption is in Income Level A. The total value is 726,400. The value is frozen when they qualified for this exemption at 479,700. Since they are in Income Level A they get a further reduction of 60% or 60,000 whichever is greater. In this case it's reduced 60% of the frozen value so the taxable value is 191,880. FYI...if they were in Income Level C the taxable value would have been 479,700.
